## THE GENERAL INSTRUCTION FOR FILLING UP OF APPLICATION FORM FOR SUPPLEMENTARY HSC EXAMINATION, 2025

1. The students of all recognised secondary schools shall fill up their application forms for appearing at the Supplementary HSC Examination, 2025 through the Head of the Institutions who have enrolled those students.
2. The following category of school students can fill up their application forms for appearing at the Supplementary HSC Examination, 2025 whose authority to fill up the application forms shall be their Head of the Institution.
  - (a) The candidates who are secured "F" grade or have remained absent or booked under "MP" in Annual HSC Examination, 2025 in regular and quasi regular category are eligible to appear the Supplementary HSC Examination, 2025 as regular and quasi regular category respectively.
  - (b) All other candidates who have appeared the examination at least once and were unsuccessful either due to securing "F" grade or remaining absent or booked under malpractice are also eligible to appear in all the subjects in the existing Board's syllabus of 2024 under ex-regular category.
3. The following category of Correspondence Candidates can fill up their application forms for appearing at the Supplementary HSC Examination, 2025 whose authority to fill up the application forms shall be the Deputy Secretary of concerned zones.
  - (a) The regular correspondence course candidates who have secured "F" grade or have remained absent or booked under MP in Annual HSC Exam, 2025 are eligible to appear the Supplementary HSC Examination, 2024 as correspondence Course Regular (CR).
  - (b) Other correspondence course candidates who have appeared and have been unsuccessful in the previous Class-X HSC Board Examination prior to 2024 or during 2013 are eligible to appear under the student category correspondence course ex-regular (CE).
4. The list of regular candidates who were unsuccessful "F" grade, "ABS" & "MP" in Annual HSC Examination, 2025 shall be displayed along with the candidates who did not appear the Annual HSC Examination, 2025 under "Registration Regular". The Head of the Institution has to select the candidates from this list for appearing under "Regular" category.
5. For Ex-Regular category, the Head of the Institution has to enter the Roll No., UIN No. & year of the examination of candidates in which he/ she has last appeared. Entering year & Roll No. of previous examinations shall not find the candidate for appearing the exam.
6. The head of the institutions should fill up the script (writing language) of other subjects such as Mathematics, General Science & Social Science. The entry of script shall be required if the 1<sup>st</sup> language subject of the candidate is other than Odia.
7. The Vocational candidates who have "F", "ABS" & "MP" under result grade at Annual HSC Examination, 2025 shall appear practical examination if they have failed in practical examination, i.e. if they have scored less than 15 marks in practical. They shall not appear the practical examination if the mark scored by them is 15 or more. Moreover the candidate appearing the examination for the 1<sup>st</sup> time shall appear at the practical exam.

Fee structure for filling up of application forms is as follows :-


